BASIC INFORMATION

1. All competitors must be individual members of USA Shooting from Zone 8 (NM, OK, TX).
2. If your membership is expired your scores will not be entered into the USA Shooting classification system.
3. All Smallbore Rifle and Air Rifle events will be conducted using multiple targets approved by USAS.
4. All Air Pistol events will be conducted using manual/electronic target carrier systems.
5. Open finals (including juniors) will be conducted at the end of each event in all Olympic events.

RULES

This competition is governed by current USA Shooting Rules and any Match Director's bulletins posted for this competition. It is the competitor's responsibility to be familiar with the USA Shooting Rules and follow all provisions thereof.

ENTRY INFORMATION

Early Entry Fees are \$25.00 per competitor per event if received before or on July 7th, 2007. Regular Entry Fees are \$30.00 per competitor per event if received after July 7th, 2007.

1. \$8.00 USA Shooting registration fee per competitor per event will be sent to USA Shooting with your scores.
2. In order to increase participation in the 2007 USAS Zone 8 Championships and make it more affordable for shooters participating in two and more rifle and/or pistol events the following entry fees are set:

REGISTRATION

1. All competitors must be individual USA Shooting members and provide their USA Shooting membership number.
2. USA Shooting classification system will be used.
3. Competitors must check in and verify their entry information.

EVENTS SCHEDULE

1. 10M 3 Position Air Rifle event will be conducted at the same time/relays with the 10M Precision Air Rifle event.
2. Finals for 10M Air Pistol and 10M Air Rifle will be conducted for Women and Men together if possible, based on the total number of shooters in each final.
3. 50FT 3x20 Rifle Women and 50FT 3x40 Rifle Men events will be conducted after 50FT Prone Rifle Women/Men event and first 20 shots (Women), first 40 shots (Men) in prone events will be counted as a first position (prone) in 50FT 3x20 Rifle Women and 50FT 3x40 Rifle Men events.
4. Finals for 50FT Prone Rifle event will be conducted for Women and Men together if possible, based on the total number of shooters in the final.

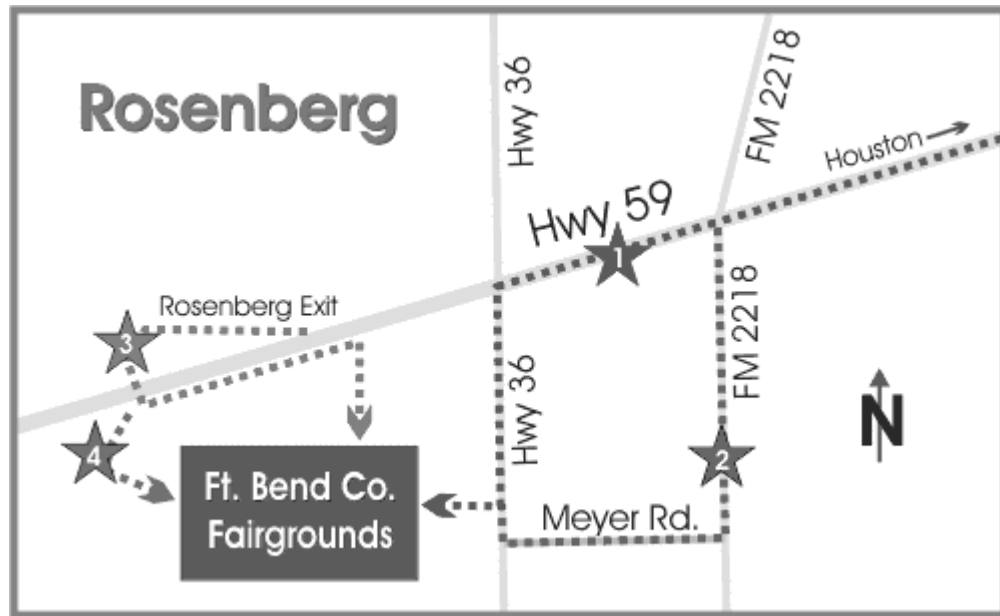
